#### 07.03 To receive reports

**CCIIr Kemp** report can be viewed on the website or at the clerk's office. An application had been received to install a footpath at the bottom of Skates Hill. Unfortunately there are no funds available for this.

**DCllr Holt** reported works will commence on the access track at the top of Angle Lane on the  $14^{th}$  March, this should take 1-2 weeks.

There is to be an increase in council tax by BDC.

The management restructure at BDC is causing redundancies.

At the recent cluster meeting at BDC potential sites for development were looked at. At this present time there is very little detail. The Parish Council will be informed when more information becomes available.

BDC building control has now moved totally over to Needham Market.

SER CO are to continue their association with BDC. Safe Partnership, working with Babergh and

Mid Suffolk District Councils has successfully secured a one-off grant from the Suffolk Community Fund that could help enable victims of domestic abuse and their families remain in their homes by providing free, and immediate, home security measures.

**DCIIr Plumb** advised on the devolution process. The original plan was to include Suffolk, Norfolk, Cambridge and Peterborough. The latest idea is to also include north Essex (all parts of Essex that are not in greater London). This will become a relatively large area. This is all very driven by Government.

There are over 600,000 outline planning permissions in the country which have been granted but not yet developed.

## 09.03 Public Question time

Enquiries were made about issues concerning the lack of high speed broadband in the Kings Rd/Brices Way area. The clerk is to look into this. James Cartlidge MP is also to be contacted. Representative from  $2^{nd}$  Avenue gave thanks to the Parish Council for help with issues about the problems with AWA. The help was very much appreciated.

A report from a tree surgeon has highlighted concerns about trees within the Cemetery, Church Yard and surrounding area. The Church warden is to be sent a copy of the letter.

## 12.03 Parking on greens - solutions to

Many concerns have been raised about parking on greens in the village, particularly in the Broadway, Schoolfields area. Suggestions were made to enquire with Suffolk County Council about additional parking bays and BDC councillors will look into issues on BDC owned land. With regards the area on the Broadway (on which the bus shelter stands) which is owned by the Parish, *it was resolved* to plant trees to stop this problem.

## 15.03 Telecommunications mast - discussions on possibility of

It was agreed to look into making enquiries about the possibility of a communications mast in the vicinity of the village hall/playing field areas.

## 16.03 Village hall toilet refurbishment - amendment to quote

*It was resolved* to accept the amendment of £1500 to the quote for the refurbishment of the village hall toilets due to upgrade of tiles, vanity units, plastering etc and to pay an initial £8000 deposit.

## 17.03 Village hall - velux windows

*It was resolved* to take a retrospective vote for emergency repairs to the velux window in the village hall at a cost of £940.00

#### 18.03 Village Hall - heating

Unfortunately three heaters in the village hall have had to be disconnected as they are unsafe. The clerk is to obtain quotes for a new heating system, to incorporate a false ceiling and new lighting.

## 19.03 Village hall - upgrade to super fibre optic broadband

An offer has been received from BT to upgrade the broadband at a lower cost (£3.25 less than currently paying). *It was resolved* to go ahead with this.

## 20.03 Woodlands - request to amend rental charges

Woodlands children's services have requested a drop in their village hall rental charges. The clerk is to check how many hours are required and for what duration.

# 21.03 Craft afternoon, 29th March - free use of village hall

It was resolved to allow free use of the hall.

# 22.03 Correspondence to report

An outline proposal for a Glemsford Heritage Centre has been received from the history society. It is requested that this be considered in the proposed redesign/rebuild of the village hall. It was agreed that in principle there is no objection to this, but the exact location would need more consideration when the plan is finalised.
